Bethel in the Hills Campground is located off the I-5 Freeway North of L.A. Exit Frazier Park Rd. Go west 20 min. Turn left onto Steinhoff Rd. Turn right on Shaffer and left on Dorothy Lane.

Signs with our So Cal Youth Logo will be up to help lead the way!

- Be informed that we will use Youth Pastors and Youth leaders before we draw from our other applicants.
- If, for any reason, the area you desire to work is unavailable, please be prepared become apart of our invited team members. There is always a job to be done somewhere.
- If you use any prescribed medications they must be turned into the camp nurse. Workers are not allowed to administer any medicines, including Advil, Tylenol, etc...
- Once the staff is checked in, you cannot leave the campgrounds except for emergencies and with clearance from the camp directors.
- If you chose to leave the campground early without the consent or permission of the camp directors (leaving in the middle or before the end of camp) it will prevent you from returning as a return worker to camp the following year.
- Before leaving the campground, the staff will be required to check out in the office. Chaperones, be prepared to walk through your dorm or cabin with the assistant camp director or camp directors for clearance before leaving.
- Any staff or chaperones starting or reacting (pay back) to raids will be asked to clean up all damage. Second time offenders will be asked to leave.
- All staff must have a background check. Permission for the background check is attached to the this packet. Please note that if a background check is refused that your application to work Summer Camps will not be processed.
- All workers/chaperones will pay a \$20 fee for the first camp and an additional \$5 for each camp after that. A late fee of \$5 will be applied to applicants not meeting the July 1st deadline.
